By engaging AFGE /NVAC Locals within Veterans Service Integrated Networks (VISN) concerning the relocation of current Human Resources Services and Fiscal Services for bargaining unit employees in Service Area Offices in the VHA Procurement and Logistics Office (P&LO) to be centralized to the VSC. By prior MOU the national parties have an agreement on the HR and Fiscal services of these bargaining employees. NVAC is request status quo ante relief in this matter.
