Dear Mr. Williams:

1. In accordance with the Master Agreement between the Department of Veterans Affairs and AFGE, Article 47, Section 4 (B), please find attached the proposal for consolidating short stay patients in one area.
2. The reason for this proposed change is to consolidate short stay procedures in one area rather than duplicating services in two areas. This change will also decrease the wide scope of services on Ward 4E.
