Subject: Change in Delivery of Paper W-2s & Leave & Earning Statements (LES)

Background: Effective pay period ending 3 July 2021, (pay date 9 July 2021) our payroll provider - DFAS will distribute Leave and Earnings Statements and W-2s to the employee's address on file (aka in DCPS) vs. the station/duty location. To ensure receipt please encourage employees to verify their home address and make any necessary changes in MyPay or by contacting their local payroll office **OR** (preferably) have them change their delivery options in MyPay to electronic.

NOTE: DFAS charges VA for printing and distributing per document and employee -- going electronic saves money, manpower, and additional resources.

Did you know your important documents can be delivered quicker and safer electronically through your **myPay** (<https://mypay.dfas.mil>) account? Tax documents, account statements and other information affecting your finances are available at your convenience by opting in for electronic delivery.
