

MEMORANDUM OF UNDERSTANDING (MOU)

The following constitutes an agreement between the VA Puget Sound Health Care System (VA PSHCS) and the American Federation of Government Employees, AFL-CIO, National Veterans Affairs Council #53, (AFGE Local 498) and (AFGE Local 3197) concerning the appropriate arrangements and procedures of the SOARD Maximo Program at VA Puget Sound Health Care System (VA PSHCS).

Hereinafter the parties agree to the following:

1. The parties agree to follow the provisions as outlined in the National Memorandum of Understanding (MOU), dated June 22, 2016, between the Department of Veterans Affairs, Veterans Health Administration (VHA) and American Federation of Government Employees (AFL-CIO), National Veteran Affairs Council #53 (NVAC) concerning the VHA SOARD Maximo Program Implementation.
